In order to complete your taxes, one (1) piece of Government **or** Standard ID from the lists below is required, **or** two (2) pieces of Secondary ID from the Secondary Identification list.

### Government Identification (one item from the list below)

- Partner issued ID
- Correctional Service Canada ID
- Provincial government ID
- · Photocopied government ID verified/stamped by a welfare office

### Standard Identification (one item from the list below)

- Drivers License (with photo & signature)
- Provincial health card (with photo & signature)
- University/College ID
- Passport (with photo & signature)
- First Nations Status Card (with photo & signature)

#### Secondary Identification (any two items from the list below)

- Transit Pass
- Employer ID
- School ID
- Government Health Care
- Credit/debit Card
- SIN
- Birth Certificate

- Climate Action Incentive
- Disability credits, and more

So, before you get started on your taxes, make sure you have all the receipts and income records you need.

- $\square$  Old Age Security and CPP benefits (T4A-OAS, T4AP)
- $\square$  Other pensions and annuities (T4A)
- □ Social assistance payments (T5007)
- $\square$  Workers' compensation benefits (T5007)
- $\square$  Advance Canada Workers Benefit (CWB) payments (RC210)
- $\Box$  All other information slips

## Receipts

- □ Support for a child, spouse or common-law partner
- □ Professional or union dues
- Tool expenses (Tradespersons & apprentice mechanics)
- $\hfill\square$  Other employment expenses
- □ Medical expenses
